### **Parties to the Application**

This application, along with the concurrently-filed assignment applications of the subsidiaries of Young Broadcasting Inc., Debtor-in-Possession (“Young”), requests Commission consent to assign the broadcast licenses held by the subsidiaries of Young, which are currently operating under the protections of Chapter 11 of the U.S. Bankruptcy Code in consolidated cases before the United States Bankruptcy Court for the Southern District of New York, to the reorganized subsidiaries of Young Broadcasting Inc. (“Reorganized Young”) that emerge from bankruptcy.

Upon conclusion of the bankruptcy proceedings, Reorganized Young will operate as a private company owned by its shareholders. The corporate structure of the surviving company will mirror that of the corporation prior to the bankruptcy reorganization. Each of the assignees in this and the concurrently-filed applications will remain a direct or indirect wholly owned subsidiary of Reorganized Young. After emerging from bankruptcy, Reorganized Young will own 100 percent of the following companies:

- Young Broadcasting of Richmond, Inc., proposed post-bankruptcy licensee of WRIC-TV, Petersburg, Virginia
- Young Broadcasting of Lansing, Inc., proposed post-bankruptcy licensee of WLNS-TV, Lansing, Michigan
- Young Broadcasting of Albany, Inc., proposed post-bankruptcy licensee of WTEN(TV), Albany, New York, and WCDC-TV, Adams Massachusetts
- Young Broadcasting of Green Bay, Inc., proposed post-bankruptcy licensee of WBAY-TV, Green Bay, Wisconsin
- Young Broadcasting of Davenport, Inc., proposed post-bankruptcy licensee of KWQC-TV, Davenport, Iowa
- Young Broadcasting of San Francisco, Inc., proposed post-bankruptcy licensee of KRON-TV, San Francisco, California
- Young Broadcasting of Sioux Falls, Inc., proposed post-bankruptcy licensee of KELO-TV, Sioux Falls, South Dakota, KDLO-TV, Florence, South Dakota, and KPLO-TV, Reliance, South Dakota
- Young Broadcasting of Rapid City, Inc., proposed post-bankruptcy licensee of KCLO-TV, Rapid City, South Dakota

Reorganized Young will be owned and controlled by its stockholders, no one group of which will have a controlling interest. Four parties are anticipated to hold attributable interests in Reorganized Young: Vincent J. Young; Capital Research and Management Company; The Income Fund of America, Inc.; and Lenado Partners, Series A of Lenado Capital Partners LP. No other person or entity (other than directors and officers of Reorganized Young) will have attributable interests in Reorganized Young. Further information about the attributable interest holders in Reorganized Young is set forth below.

Additionally, none of the undisclosed funds advised by Capital Research and management will hold a 5% or greater voting interest in Reorganized Young.
