In evaluating the proposed digital flash cut for K18GF FID 130211, an outgoing interference study was executed on the proposed design in the attached application using the OET-69 Longley Rice methodology. The stations listed in the table below showed possible interference. When these stations were evaluated for outgoing interference, there was zero percent interference present found in each case when rounded to the nearest whole percent.

Three Angels Broadcasting Network requests that the international coordination with Canada will be waived since the proposed 19dBu F(50,10) signal does not cross into Canadian territory. Please see the coverage map below.
