TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Cumulus Licensing LLC ("Cumulus"). Cumulus is submitting an application to correct the geographic coordinates of WGLF, Channel 281C, Tallahassee, Florida. As such, a Radio Market analysis has been prepared. Cumulus is also the licensee WBZE, Channel 255C1; WHBX, Channel 241C2; and WHBT, 1410 kHz, Tallahassee, Florida; and WWLD, Channel 272C2, Cairo, Georgia. WGLF, WBZE, WHBX and WHBT are licensed to communities within a metro county in the Tallahassee, Florida Arbitron Market. WWLD is considered "home" to the Tallahassee, Florida market. Since WWLD has contour overlap with some of the other facilities listed above, this review will verify compliance of commonly owned stations in both rated and non-rated markets.

TALLAHASSEE, FLORIDA ARBITRON/BIA MARKET REVIEW

2. As shown on Exhibit #1, there are twenty-six AM and FM (commercial and non-commercial) stations listed in the Tallahassee, Florida Arbitron Market (Market #164). Cumulus controls four FM stations and one AM station in the market. The number of stations indicated falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, Cumulus is in compliance in the rated Tallahassee, Florida market.

REVISED CONTOUR OVERLAP ANALYSIS

3. Since WWLD is a non-metro station, a study has been conducted to verify that the ownership of it, in conjunction with other stations in the Tallahassee, Florida Arbitron Market (WGLF, WBZE, WHBX and WHBT) is also in compliance with the Commission's multiple ownership rules. The city grade contours of these five stations are shown on Exhibit #2. As noted, the locations of the city grade contours of the stations create a distinct radio market requiring review.

4. The city grade contour of the proposed WGLF will be used to establish the "Radio Market Boundary" and will be used to determine the number of other stations in the market. No stations with transmitters located more than 92.0 kilometers from the boundary of the common overlap of subject stations will be considered. Further, no other facility controlled by Cumulus will be considered as a market contributor, unless it is a subject station in the radio market under study.

5. Exhibit #3 is a depiction of the AM and FM stations (commercial and non-commercial) providing service to the Radio Market boundary. Exhibit #4 is a tabulation of the stations in the Radio Market, a total of fifteen stations are shown, including the five subject stations. Cumulus controls four FM stations and one AM station in the market. The number of stations indicated falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, Cumulus is in compliance in the non-rated market.

6. Based on the compliance shown in both the rated and non-rated markets, the proposed minor change application for WGLF is in compliance with the Commission's rules, as it relates to the markets reviewed.

7. The foregoing technical statement was prepared on behalf of Cumulus Licensing LLC by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.2. BIA database. Technical data related to AM and FM facilities was extracted from the Commission's CDBS database. We assume no liability for errors or omissions in either database which may be adverse to the information contained herein.


