Dear Counsel:

This is in reference to the filing made on of June 25, 2014, on behalf of the Shamrock Communications, Inc. ("Shamrock"). Shamrock requests extension of the Special Temporary Authority ("STA") granted January 9, 2014 separately to KNEZ and KZTI and KRZQ, for continued operation at reduced power while antenna repairs are being made.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

The licensed, shared antenna system was damaged in June 2013 and, to date, Shamrock has not explained what steps it is taking toward restoring licensed operations or when it is expected that such operations might resume. Thus, we cannot conclude that any progress has been made during the past six months. Nevertheless, we will grant one extension to afford Shamrock an opportunity to address the antenna and transmission system issues. Further extension requests will only be granted if that request explains the efforts made during the past STA toward restoring licensed operation.

Accordingly, the STA requests for KNEZ and KZTI and KRZQ to continue reduced power operation ARE GRANTED. Shamrock must notify the Commission when licensed operations are restored. Shamrock must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

This Special Temporary Authority expires January 3, 2015. Again, further extensions will only be granted if that extension request explains Shamrock's efforts made during this STA period toward restoring licensed operation.
