

This exhibit demonstrates this application's compliance with 47 CFR Section 73.207.

Figure 1 is a map of the proposed coordinates verses required distances as per 73.207, ignoring the three records explained below.

Figure 2 is the tabulation of all affected stations listed by distance from the proposed coordinates. This list shows 3 records that do not meet the minimum distance requirements, but are out-dated records as will be shown.

Record 1 is the existing KHNA Construction Permit which will be amended by this application.

Record 2 is an out-dated petition to move an allocation to Cheyenne WY on channel 280 to channel 277. This petition was filed by Mountain States Radio on Feb 12, 2004 and was dismissed 9/29/2004. A construction permit BNPH-20050103AFI has been issued to College Creek Broadcasting, Inc. on channel 280. Furthermore, Mountain States Radio has since filed an application to move the station originally petitioned for (KRQU) to channel 230.

Record 3 is an out-dated record that was superseded by a one-step upgrade and channel change from 277A to 278C.

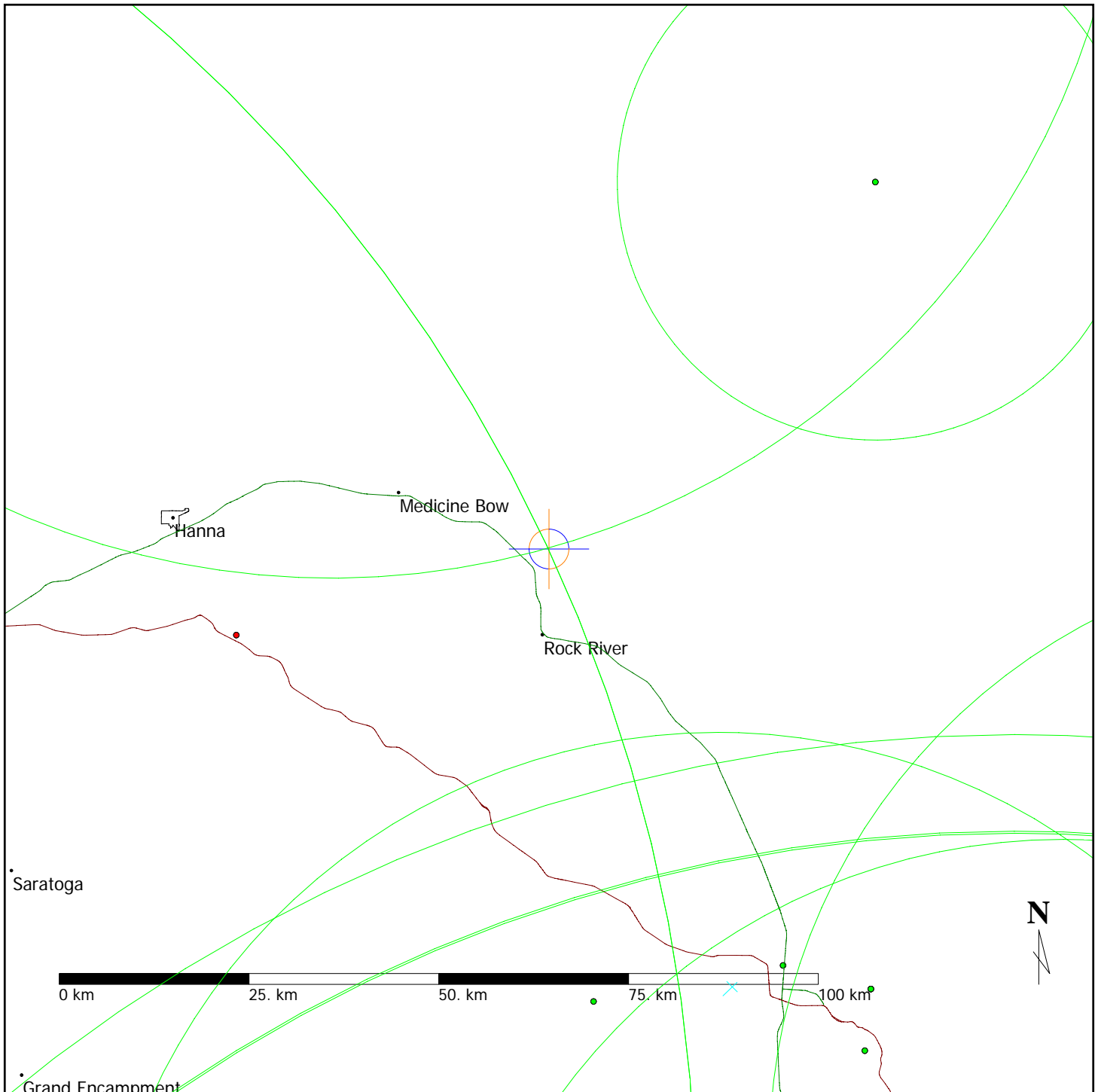
