TECHNICAL STATEMENT

1. This Technical Statement and attached exhibits were prepared on behalf of Mega Communications of Daytona Beach Licensee, LLC (“Mega”), licensee of WNUE-FM, Channel 251C1, Titusville, Florida. Mega is submitting a minor change application to relocate WNUE-FM, as such, a Radio Market analysis is needed. Mega has no other FM facilities in the state of Florida, therefore, WNUE-FM is a stand alone FM station. WNUE-FM is licensed to a community located in the Melbourne-Titusville-Cocoa, Florida Arbitron Market. WNUE-FM facility is also considered “home” to the Orlando, Florida market. Therefore, this analysis will be based only on a station in a rated market.

MELBOURNE-TITUSVILLE-COCOA, FLORIDA
ARBITRON/BIA MARKET REVIEW

2. As shown on Exhibit #1, there are twenty-two AM and FM (commercial and non-commercial) stations listed in the Melbourne-Titusville-Cocoa, Florida Market (Market #97). Mega would be in control of one FM station in the market. The number of stations indicated falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, Mega is in compliance in the rated Melbourne-Titusville-Cocoa, Florida market.

ORLANDO, FLORIDA ARBITRON/BIA MARKET REVIEW

3. As shown on Exhibit #2, there are forty-one AM and FM (commercial and non-commercial) stations listed in the Orlando, Florida Market (Market #34).¹ Mega would be in control of one FM station in the market. The number of stations indicated falls in the thirty to forty-four stations tier of §73.3555(a)(1)(ii) of the Commission's rules. At this level, common ownership or control of up to seven stations, with no more than four in the same service, is permissible. Therefore, Mega is in compliance in the rated Orlando, Florida market.

4. Based on the compliance in the two rated markets, the proposed minor change application for WNUE-FM is in compliance with §73.3555 of the Commission's rules, with regard to the above referenced stations.

5. The foregoing technical statement was prepared on behalf of Mega Communications of Daytona Beach Licensee, LLC, by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.2. BIA database. Technical data related to AM and FM facilities was extracted from the Commission's CDBS database. We assume no liability for errors or omissions in either database which may be adverse to the information contained herein.
