

MULTIPLE OWNERSHIP STUDY

The instant application seeks Commission consent to the assignment of licenses for Radio Station WROM(AM), Rome, Georgia (FCC Facility ID No. 66283), from **HEIRBORN MINISTRIES, INC.**, to **ROME RADIO PARTNERS, LLC** (“RRP”). This showing is to provide a demonstration of compliance by RRP, with the Commission’s multiple ownership rules.

Rome, Georgia, is located in the foothills of the Appalachian Mountains, and is the largest city and the county seat of Floyd County, Georgia. Rome is the principal city of the *Rome, Georgia Metropolitan Statistical Area* which encompasses all of Floyd County.

Subject to the approval of the instant application, RRP, or principals of RRP will have interests in the following broadcast/media facilities in the Rome area:

1. Radio Station WRBF(FM), Plainville, Georgia (Facility I.D. No. 171028), and FM Translator Station W258CH, Rome, GA (FCC Facility ID No. 147620);^{1/}
2. Radio Stations WRGA(AM), Rome, Georgia (FCC Facility ID No. 40856); WQTU(FM), Rome, Georgia (FCC Facility ID No. 40816), and WROM(AM), Rome, Georgia (FCC Facility ID No. 66283).
3. A Local Marketing Agreement (“LMA”) involving **COOSA BROADCASTING CORPORATION** pertaining to Radio Station WSRM(FM), Coosa, Georgia (FCC Facility ID No. 30623);^{2/} and
4. An LMA involving **WOMAN’S WORLD BROADCASTING, INC.**, pertaining to Radio Station WGJK(AM), Rome, Georgia (FCC Facility ID No. 7044).
5. An officer’s position with Cox Radio, Inc., and the broadcast stations shown on **Attachment A**, hereto

N.B.: The instant assignment application is part of an exchange transaction whereby RRP will exchange Radio Station WZOT(AM), Rockmart, Georgia (FCC Facility ID No. 7041) in return for Radio Station WROM(AM), Rome, Georgia (FCC Facility ID No.

^{1/} Plainville, Georgia, is located approximately 12.5 miles (20.2 km) north-north-east of Rome, Georgia. These stations are owned individually by Howard C. Toole.

^{2/} Coosa, Georgia, is situated approximately 15 miles (24.1 km) west-south-west of Rome, GA.

66283). Hence, for multiple ownership purposes, there will effectively be *no* increase in the number RRP’s current station ownership interests.

Aside from the afore-referenced facilities, neither RRP, nor any of its other principals have any other broadcast or media interests Thus, RRP, will have an attributable interest in a total of six radio broadcast stations – three (3) FM stations and three (3) AM stations in the defined market.

As a result, compliance with the Commission’s multiple ownership rule is to be determined under the interim contour overlap method as outlined in the June 2, 2003 Report & Order in MB Docket No. 02-277 *et al.* As reflected by the attached engineering analysis (**Attachment B**), the market for the six radio stations really is defined by the primary service contours for the six above-referenced stations. That market, which is determined by using the FM 70 dBu (3.16 mV/m) and the AM 5 mV/m contours, contains twenty-three (23) radio stations. That includes both commercial and non-commercial FM and AM stations.


Section 73.3555(a)(iii) of the Commission’s Rules provides that in a radio market with between fifteen (15) and twenty-nine (29) full-power commercial and non-commercial radio stations, a single entity, or entities under common control, may have a cognizable interest in licenses for not more than six (6) commercial radio stations, in total, and not more than four (4) commercials stations in the same service. Given the fact that, optimally, RRP will have an interest in a total of six (6) commercial stations, three (3) of which are FM stations and three (3) of which are AM stations, RRP is in compliance with Section 73.3555(a) of the Rules.

Accordingly, it is respectfully submitted that the instant assignment application of RRP to acquire Radio Station WROM(AM), Rome, Georgia (FCC Facility ID No. 66283) – in exchange for Radio Station WZOT(AM), Rockmart, Georgia (FCC Facility ID No. 7041) – is in full compliance of Section 73.3555 of the Commission’s rules and, therefore, ought to be granted.
