Dear Mr. Denning:

This is in reference to the request filed on June 27, 2017. RLH requests a further extension of the STA originally granted on May 9, 2007, to continue operating using the facilities specified in BP-20160920ADJ.¹ In support of the request, RLH stated that additional time is needed to complete all work before filing the required FCC Form 302 application to obtain a new license.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of STA IS HEREBY GRANTED, and RLH may operate with parameters at variance using the existing tower specified in BP-20160920ADJ with the maximum authorized power levels of 0.3 kW daytime and 0.011 kW at night (and may NOT use higher requested power levels). RLH must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure

¹ WIBR(AM) is licensed for DA operation on 1300 kHz with 5 kW day and 1 kW night, and BP-20160920ADJ authorizes use of one of the WXOK towers with reduced power (day and night).

guidelines. *See* 47 CFR § 1.1310.

This authority expires on **December 31, 2017**.
