

Technical Narrative

Overview

Indexed, contingent minor changes to three operating stations are proposed. The instant minor change application seeks a new community for WKOV-FM. The second minor change seeks a voluntary channel change to a non-MX channel with no change in class for WCMJ-FM. The third minor change seeks a voluntary change of transmitter site with no change in community or channel for WBIK-FM.

Grant of these proposals would provide a first local transmission service for the deserving community of Frazeytsburg, Ohio. The proposal is described herein in the entirety for the convenience of the FCC staff but the actual requests are made by the applications themselves unless otherwise directed by the Report and Order in Docket 05-210.

I. Modification of WKOV-FM from Wellston, OH to 244B1 Frazeytsburg, OH

WKOV-FM 244B1 Wellston, OH (Facility ID Number 29691) seeks to be modified to channel 244B1 as a new first local transmission service to the community of Frazeytsburg, Ohio. The proposed reference site of 40° 03' 06" North Latitude 82° 12' 00" West Longitude for WKOV is mutually exclusive with the licensed facility of WKOV. This modification is compliant with all the requirements of 47CFR §73.207 and 47CFR §73.315. The WKOV-FM application site is located at 40° 01' 36" North Latitude 82° 10' 38" West Longitude.

The Wellston and Frazeytsburg allotments share no overlap of hypothetical interference free service. Re-allotment would provide a gain of 300,006 persons in an area of 6,279 square kilometers. The loss area is 6,279 square kilometers and contains 169,511 persons. The entire loss area receives five or more services.

The modification to change city of license of WKOV(FM) to Frazeytsburg, OH requires a specially coordinated short-spaced allotment with Canada. The proposed short-space is with CHYR 244C1 Leamington, ON. CHYR is a specially negotiated short-spaced channel. CHYR operates with restricted power and HAAT and a directional antenna protecting a number of U.S. FM stations. The interfering contours from the proposed WKOV-FM 244B1 at Frazeytsburg, OH (both the hypothetical allotment reference site and the application site) do not extend beyond the U.S – Canadian border at any point. It is believed the proposed allotment complies with the Section 3.5.1 of the U.S./Canada FM Agreement. See Exhibit 23 for details and contour maps for Industry Canada/CRTC notification.

II. Change Channel of WCMJ-FM to 274A Cambridge, OH

Channel 274A can be assigned in compliance with 47CFR §73.207 at the present licensed site of WCMJ(FM), Cambridge, OH (Facility ID Number 3362). The licensee of WCMJ, AVC Communications has agreed to this proposed modification. The change is detailed more fully in the WCMJ-FM Form 301 pursuant to the Report and Order in Docket 05-210.

III. Change Transmitter Location of WBIK-FM 221A Pleasant City, OH

Station WBIK can be relocated to a new transmitter site. The proposed application site is 40° 02' 01" North Latitude 81° 31' 07" West Longitude. This site change is necessary to avoid an Intermediate Frequency (IF) short-spacing with the proposed Channel 274A, WCMJ-FM at Cambridge, OH. The licensee of WBIK-FM, David L. Wilson, has agreed to the proposed modification.

A channel study depicting the proposed channel change is included where appropriate in the WBIK-FM Form 301 pursuant to the Report and Order in Docket 05-210.

Summary

As the foregoing demonstrates, the net result of these minor change proposals is first local transmission service to a worthy Ohio community of 1,201 residents. No community would suffer the loss of its sole transmission service. Additional interference free service choices would be available to some 300,006 persons in 6,279 square kilometers while only 169,511 persons would have one fewer reception service in the aggregate area of 6,279 square kilometers. All loss areas will continue to enjoy no fewer than five interference-free reception services. There are no individuals that would be underserved as a result of the plan put forth in this proposal.
