**Dallas-Fort Worth, Texas DMA**

The triggering of the Commission's local radio ownership rule, 47 C.F.R. Section 73.3555(a), and the radio-television cross-ownership rule, 47 C.F.R. Section 73.3555(c), due to the attributable, non-controlling interests of certain parties to the Transferee will not have any adverse effect on the multiplicity of media voices in the Dallas-Fort Worth, Texas, area because, as demonstrated herein, the area's residents have access to a large variety of local broadcast and non-broadcast media.

The Dallas-Fort Worth, Texas Designated Market Area (the "Dallas-Fort Worth DMA") is ranked as the seventh largest market in the nation by Nielsen Media Research. 1/ As set forth in Table G-1 hereto, the Dallas-Fort Worth Arbitron Metro radio market has 13 independent television voices and 46 independent media voices, as calculated pursuant to 47 C.F.R. Section 73.3555(c)(3), far in excess of the eight independent television voices and 20 independent media voices required for a two television/six radio station combination.

The Dallas-Fort Worth DMA has a total of 18 commercial and non-commercial full-power television stations. 2/ These 18 television stations include affiliates ABC, CBS, NBC, FOX and PBS, as well as six independent stations. 3/ Both before and after consummation of the proposed transaction, these 18 television stations will be owned by 13 different entities. 4/

In addition to the full-power television stations, there are 19 low-power television stations (including two Class A stations) in the Dallas-Fort Worth DMA, many of which provide additional programming to viewers, including, for example, an Azteca network affiliate (KODF-LP, Britton), a LAT TV network affiliate (KJJM-LP, Dallas), and a Multimedios network affiliate (KATA-CA, Mesquite) all of which provide Spanish-language programming. 5/

The Dallas-Fort Worth DMA also is served by a vibrant and diverse radio market, including 52 FM stations and 33 AM stations. 6/ The radio services available to residents in the DMA include Spanish-language programming (*e.g.*, KFJZ(AM), Fort Worth; KFLC(AM), Fort Worth), religious programming (*e.g.*, KVTT(FM), Dallas) and sports programming (*e.g.*, KTCK(AM), Dallas), in addition to a wide variety of other talk and music formats. 7/

The Dallas-Fort Worth market also is well served by multi-channel video programming distributors ("MVPDs"). Over 78 percent of households in the Dallas-Fort Worth DMA subscribe to some form of MVPD, 8/ most commonly cable television, which has a penetration rate of 47 percent (1,066,450 households) and is provided over 92 separate cable

systems owned by 16 different cable operators. <sup>9/</sup> In the Dallas-Fort Worth DMA, cable subscribers have access to substantial programming of local interest beyond their local broadcast stations. As just one example, in Terrell, residents are served by Cebridge Connections, which carries over 150 video program channels, including community access channels, as well as an entire programming tier dedicated to Spanish-language programming. <sup>10/</sup>

DBS providers EchoStar and DirecTV both serve subscribers in the Dallas-Fort Worth DMA, and both offer local-into-local delivery of Dallas-Fort Worth broadcast television stations to their Dallas-Fort Worth subscribers. <sup>11/</sup> Dallas-Fort Worth residents also have access to two Satellite Digital Audio Radio Services, Sirius and XM Radio, each offering nearly 200 digital audio channels. <sup>12/</sup> Additionally, Dallas-Fort Worth residents are situated in one of the first metro areas in the nation to have access to IPTV services. <sup>13/</sup> Verizon began the roll-out of its nationwide IPTV network, FIOS, in Keller, Texas, 30 miles outside of Dallas, in 2005. <sup>14/</sup>

In regard to the newspaper market, 11 daily and 39 weekly newspapers are published in the Dallas-Fort Worth DMA. 15/ Dallas-Fort Worth residents benefit from a large selection of local print media, including both daily (*e.g. Al Dia*) and weekly (*e.g. Novedades News*) Spanish-language publications, as well as many other publications catering to the particularized needs, interests and concerns of communities within the DMA, including the *Texas Jewish Post*, the *National Christian Reporter* and the *Baptist Standard*. 16/

Given the presence of strong competition and a great diversity of voices in the Dallas-Fort Worth DMA, grant of a temporary waiver is consistent with Commission precedent and would serve the public interest by facilitating the prompt consummation of the proposed multi-station, multi-market transaction and an orderly process for achieving compliance with the Commission's ownership rules.
