An application also currently is pending for consent to assign the licenses for WCTI-TV, New Bern, NC (Facility ID No. 18334) and its paired digital television station, WCTI-DT (“WCTI”), from Eastern North Carolina Broadcasting Corporation to Newport Broadcasting Inc. *See* FCC File No. BALCT-20040114ADZ. Due to the restrictions contained in Section 73.3555(d) of the Commission’s Rules (the “Daily Newspaper Cross-Ownership Rule”), Providence Equity Partners IV L.P., Providence Equity Operating Partners IV L.P., and their affiliated entities, have *not* proposed to obtain attributable interests in WCTI. WCTI currently is commonly-owned with the other television licensees identified above (namely, Appalachian Broadcasting Corporation, Abilene-Sweetwater Broadcasting Company, California Broadcasting, Inc., and Eagle Communications, Inc.). Freedom Communications Holdings, Inc., through wholly-owned subsidiaries, owns daily English-language newspapers serving the same communities as those served by WCTI (*i.e.*, the New Bern Sun Journal, the Jacksonville Daily News, and the Kinston Free Press).
