**As the Commission's records reflect, Augusta Radio Fellowship Institute, Inc. ("ARFI") is a non-stock, not-for-profit educational corporation. ARFI has numerous educational and instructional objectives that it meets through the operation of its noncommercial, educational broadcast stations. In general, these objectives are wide ranging and include the following:**

**To provide religious instruction and moral teaching to the general public and meet the specific needs in these regards of the citizens in the communities served by its broadcast stations;**

**To provide educational and instructional programming aimed at the educational needs and interests of diverse segments of the population within the service areas of its stations;**

**To provide information and discussion in the areas of contemporary social and religious issues and problems and solutions to such problems, such as drug and alcohol abuse, pornography, indecency, the breakdown in the family and crime;**

**To provide educational programming for children;**

**To provide moral frameworks and philosophies to assist individuals to meet the demands of life in American society, to enhance family life and to encourage the religious and spiritual development of individuals.**

**In response to the educational purposes and objectives of ARFI, the proposed station will broadcast programming consistent with the programming presently carried on co-owned station WLPE(FM), Augusta, Georgia. Such programming consists, in part, of the following:**

**Back To The Bible:** A daily program of Bible teaching and instruction by W. Kroll.

**Stories of Great Christians:** Dramatic historical presentations of Christian leaders.

**Thru The Bible:** A daily educational course with study notes and outlines presented by J. McGee.

**In Touch:** A daily program presented by Pastor Charles Stanley with lectures dealing with Bible topics.

**II. SOCIAL AND RELIGIOUS ISSUES AND PROBLEMS**

**Guidelines For Living:** A daily program of moral and religious insight.

**Unshackled:** A daily presentation of true stories on drug use, alcoholism, sexual promiscuity, gambling and other social and moral problems and solutions to these problems from the Bible.

**Focus on the Family:** A daily program from Dr. James Dobson dealing with a variety of social issues and problems with solutions for them.

**Adventures In Odyssey:** A dramatic presentation to teach by example the ways to deal with social and moral conflicts in day-today life.

**III. EDUCATIONAL PROGRAMMING FOR CHILDREN**

**Science, Scripture and Salvation:** A weekly program discussing scientific information and Biblical teaching.

**Good News Club:** An information program on topics of interest to children.

**Bookshelf:** A program on books for children.

**Kids Quest:** A weekly program on topics of interest to children.

**Uncle Bill:** A program of teaching on topics of interest to children as told by Uncle Bill.

**Ranger Bill:** A dramatic program intended to give children positive examples of courage and integrity in daily life.

**IV. MORAL AND PHILOSOPHICAL TEACHING**

**Gateway to Joy:** A daily program on finding joy in life.

**Family Life Today:** A daily program on meeting the changes of the family in American society.

**Moody Presents:** A weekly program giving Biblical perspectives on day-to-day events and presented by Dr. Joseph Stowell, President of The Moody Bible Institute of Chicago.

**Psychology For Living:** A daily program giving perspectives on dealing with the problems of daily life.

**Haven To Rest:** Christian spiritual programming and perspectives.

These programs are illustrative, but not exhaustive, of the programming that will be carried on the proposed noncommercial FM station by ARFI.
