

## EXHIBIT 9

The proposed *pro forma* transaction is an internal restructuring of subsidiaries of Radio One, Inc. ("ROI"), the party that ultimately controls the current and proposed licensee entities. This application does not request approval for any change in the ownership of ROI itself and the assignments will be among subsidiaries wholly owned or controlled by ROI. Since the changes are internal in nature, they are not the subject of formal agreements.
