Designation of AM Primary Station Pursuant to 47 C.F.R. §74.1251(c)

Dear Ms. Dortch:

Tower Above Media LLC (“Tower Above”), licensee of FM translator station W282AX, Gaffney, South Carolina (the “Translator”), acting pursuant to Section 74.1251(c) of the Commission’s rules and paragraph 19 of the Commission’s *Report and Order in Amendment of Service and Eligibility Rules for FM Broadcast Translator Stations*, MB Docket No. 07-172, FCC 09-59 (released June 29, 2009) (“*Report and Order*”), hereby notifies the Commission that the primary station being rebroadcast by the Translator is radio station WZZQ(AM), Gaffney, South Carolina (Facility ID No. 23005) (the “AM Primary Station”), which is licensed to Gaffney Broadcasting, Incorporated.

The Translator was granted a Special Temporary Authorization (“STA”) (File No. BLSTA-20090731AET) on August 18, 2009, to permit the programming of the AM Primary Station to be rebroadcast by the Translator pending the effective date of the new rules established in the *Report and Order*. As demonstrated in Tower Above’s STA request, no portion of the Translator’s 60 dBu contour extends beyond the smaller of (i) a 25-mile radius from the AM Primary Station’s transmitter site, or (ii) the 2.0 mV/m daytime contour of the AM Primary Station.


Since the filing of the STA Request, there have been no changes in the technical facilities of either the Translator or the AM Primary Station. Moreover, the Translator had a license in effect as of May 1, 2009 (File No. BLFT-20070802ACE, granted August 22, 2007). Tower

Above recognizes that, in accordance with the *Report and Order*, its existing STA will be dismissed.
