

ASSIGNEE'S EXHIBIT 10
DESCRIPTION OF THE TRANSACTION

This application is one of a series of concurrently filed applications seeking FCC consent to the *pro forma* assignment of the licenses held by the various licensee entities identified below, each of which is under the control of NV Media, LLC (“NV”). On July 13, 2009, NV, along with its subsidiaries and affiliates, submitted a voluntary petition for bankruptcy to the United States Bankruptcy Court, District of Delaware, seeking to reorganize under Chapter 11 of the U.S. Bankruptcy Code.¹ Each licensee subsidiary is now operating as a debtor-in-possession under the Bankruptcy Court’s oversight, and it is anticipated that each will continue operations in the ordinary course throughout the Chapter 11 process. NV and Licensee’s Petitions for Bankruptcy, as well as a copy of the Bankruptcy Court’s order, are attached to Exhibit 5.

This assignment does not effect a substantial change in the control of the licensees, as the officers and directors of NV remain unchanged following the filing of the bankruptcy petition. The control structure of the NV licensee subsidiaries remains unchanged but is now subject to the jurisdiction and oversight of the bankruptcy court overseeing this voluntary reorganization. Accordingly, the contemplated assignment is *pro forma* in nature.
