**STATEMENT TO UPDATE THE RECORD**

Bible Broadcasting Network, Inc. (“BBN”), by its attorneys, pursuant to Section Title 47 C.F.R. § 1.65, hereby updates the record in this application proceeding.<sup>1</sup> There is pending an “Application for Review” filed November 22, 2011, by Berks Radio Association (“BRA”) relative to the *Letter Decision on Reconsideration* of the Media Bureau’s Audio Division released October 24, 2011, in the above-captioned proceeding, and related pleadings. The *Letter Decision on Reconsideration* denied BRA’s Petition for Reconsideration of the grant of a construction permit to BBN for a new noncommercial educational FM station at Leesport, Pennsylvania. Call letters “WYBQ” have been assigned.



This Statement is filed to update the record to report that on August 8, 2013, BBN filed an application (File No. BLED-20130808AAO) for a license to cover the above-captioned construction permit for Station WYBQ. On August 21, 2013, the Media Bureau granted the license application.


