

Section 73.203 One Step Channel Change
Allotment Study

The Applicant respectfully requests that KUPI be allowed to change its channel from 256C1 to 256C1 at new allotment coordinates, through the use of a one-step application.

Fully Spaced Allotment Coordinates

In order to use a one step application a set of fully spaced Allotment Coordinates must be provided pursuant to Section 73.207 of the Commission's rules towards all other facilities.

The applicant has selected Allotment Coordinates for KUPI to be co-located at the licensed antenna site of KADQ (FM) Rexburg, ID, at the following coordinates:

N43-39-00, W112-09-12

As shown in the attached One-Step Allotment Channel Study, at these Allotment Coordinates, KUPI on 256C1 would be fully spaced per Section 73.207 to all other stations. At this location, KUPI is only mutually exclusive with its currently licensed site (on channel 256C1). From the coordinates proposed herein, KUPI places an F(50,50) 70 dBu contour over 100% of its Community of License – Idaho Falls, ID. Also, from the proposed Allotment Site, KUPI has unobstructed line of sight to all of Idaho Falls. Therefore, KUPI may request the one step channel change to 256C1 to 256C1 at new allotment coordinates at Idaho Falls, ID.


