**Purpose of Application**

247 Media Ministries (“Media Ministries”), the proposed assignee of KYOZ(AM), Spokane, Washington (Facility ID No. 65985), (the “Station”) (See LMS File No. 0000189261), hereby submits this FCC Form 302-AM License Application to convert the station from a commercial to non-commercial educational status upon consummation of the referenced assignment.

**247 Media Ministries**  
**Statement of Educational Purpose**

247 Media Ministries is a domestic non-profit corporation that was organized under the laws of the state of Oregon on September 18, 2018. The primary purpose of 247 Media Ministries is to create a listening and online community who experience God through worship and God's Word, which results in service to others, especially the poor. We are qualified to hold the license of KYOZ, Spokane, Washington, FCC Facility ID #65985 and will use FM Translator K239CL, Spokane, Washington, Facility ID#147992 in connection with the KYOZ.

***Educational Purpose and Advancement.*** 247 Media Ministries believes in the power of Jesus Christ to change lives. Its mission is to ignite a passion for God through worship that leads to a life of discipleship, evangelism, generosity and service to the poor. Through terrestrial and online radio stations our programs serve and represent all ages and walks of life. 247 Media Ministries will use its broadcast license to further its mission and expand its reach. Through music programming, educational features called "Go Deeper," through partnerships with other local ministries, and through service projects we will further its educational purposes by creating and broadcasting religious programming to serve its various ministries.

All operations will be conducted on a non-commercial basis and in full compliance with the rules and regulations of the Federal Communications Commission. Our funding comes from listener support and 247 Media Ministries intends to honor the commitments set forth in this assignment application.

In view of the foregoing, 247 Media Ministries is an educational organization and has evidenced its intention to operate Station KYOZ-AM in a manner consistent with an overall educational program. Accordingly, the nature and educational purposes of 247 Media Ministries make it eligible to obtain the broadcast authorization sought in the application.
