## **PURPOSE AND SCOPE**

This Engineering Statement has been prepared on behalf of For The Love Of The Game Broadcasting, LLC (“GAME”), applicant for the assignment of license of the following broadcast facilities:

GAME is currently the licensee of the following FM broadcast facilities:

The attached Figure 1 show the relationship of the FM 70 dBu contours and AM 5.0 mV/m contours of the above related facilities. As shown, KATX(FM) and KWBY-FM are not in the immediate area of the four subject stations and their 70 dBu contours are not overlapped by the contours of any of the four subject stations. No further consideration of KATX(FM) or KWBY-FM is required.

## **DEFINED MARKETS**

Figure 2 shows the overlaps of the above related facilities and defines three markets of interest.

### **MARKET #1**

Market #1 is created by the overlap of the KSWA(AM) 5.0 mV/m contour and the KWKQ(FM) 70 dBu f(50,50) contour. This market consists of a single FM and single AM affiliated facility. No further consideration of the market is required.

## MARKET #2

Market #2 is created by the overlap of the 5.0 mV/m contour of KROO(AM), the 70 dBu contour of KLXK(FM) and the KWKQ(FM) 70 dBu contour. This market consists of one affiliated AM facility and two affiliated FM facilities.

## MARKET #3

Market #3 is created by the overlap of the 5.0 mV/m contour of KROO(AM) and the 70 dBu contour of KLXK(FM). This market consists of a single FM and single AM affiliated facility. No further consideration of the market is required.

## NON-AFFILIATED FACILITIES

Figure 3 shows the 70 dBu contours of the two affiliated FM stations (KLXK(FM) and KWKQ(FM)) and the affiliated AM station (KROO(AM)) that make up Market #2. Also shown on Figure 3 are the 70 dBu f(50,50) contours of five non-affiliated FM stations listed below. These 70 dBu contours overlap one or more of the affiliated contours defining the market.

Market #3 contains three affiliated stations and, at a minimum, five non-affiliated facilities. The three affiliated stations represent less than 50% of the facilities in the market.




