Dear Licensee:

This is in reference to the request filed on June 20, 2016 for Radio 74 Internationale ("R74I"). R74I requests a second extension of the June 9, 2015 special temporary authority ("STA") to operate Station KRSF with temporary facilities. R74I now holds construction permit BPH-20160317ABN but has not yet had time to implement permanent operation.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

We find that R74I is making progress toward a permanent solution. Accordingly, the request for STA extension IS HEREBY GRANTED. Station KRSF may continue to operate with the following facilities:

Effective radiated power:	0.25 kilowatt (H&V only)
Antenna height:	
above ground:	10 meters
above mean sea level:	752 meters

R74I must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.
