

Changes in Interests

Legal Control of Gannon University resides with the Board of Trustees. The instant application is being filed to notify the Federal Communications Commission of the gradual change in the membership of the Board of Trustees of Gannon University and to obtain FCC consent for the current membership. Licensees are required to request Commission approval if membership of the controlling body of the licensee is changed by more than 50%, even if that change is incremental. This application is being filed to bring the licensee into compliance with the Commission's Rules.
