


Other Attributable Interests

Through a series of interrelated companies, NCA Radio, LLC shares some common ownership interests and management control in New Northwest Broadcasters, LLC, the licensee of 43 radio stations licensed to communities in the states of Washington, Oregon, Alaska and Montana.
