ORDER AUTHORIZING EMPLOYMENT OF COUNSEL

John W. Richardson, Trustee in Bankruptcy of the estate of the above Debtor has submitted an application for an order authorizing him to employ the law firm of Dentons US LLP, as his counsel. Having considered the application, the declaration of proposed counsel, and it appearing that employment of counsel will be in the best interest of the estate, that counsel represents no interest adverse to the estate, and that notice and a hearing are not necessary in connection with the proposed employment; it is

ORDERED as follows:

1. John W. Richardson, Trustee in Bankruptcy, is authorized to employ the law firm of Dentons US LLP, as his counsel under 11 U.S.C. § 327 to assist him in all matters arising in or related to this Chapter 7 proceeding, including, but not limited to:

- (a) Assist and advise the Trustee on legal aspects involved in the investigation, collection and liquidation of potential assets of the estate;

- 1 (b) Assist and advise the Trustee regarding any transfers which may be avoidable
2 under the provisions of the Bankruptcy Code;
3 (c) Represent the Trustee in litigation she determines is necessary;
4 (d) After Applicant's review, and if the Trustee requests, assist the Trustee in the
5 objection to claims; and
6 (e) Attend Court hearings as necessary.

7 2. Any compensation to be paid to Dentons US LLP, shall be on an hourly rate basis
8 and is subject to Court approval on application in conformity with the Court's guidelines, and on
9 notice to creditors, the United States Trustee, and other interested parties.
