**Motion for Extension of Time**

NIA Broadcasting, Inc. ("NIA"), licensee of FM Translator Station W248CA, St. Petersburg, Florida, by its attorney, hereby respectfully requests the Audio Division to extend the time in which to respond to the Commission's November 6, 2017 Letter, Ref. No. 1800B3-PPD from James D. Bradshaw of the Audio Division ("Staff Letter") pertaining to certain Interference Complaints submitted by Hall Communications, Inc., ("Hall") against NIA translator operations.

An extension for thirty (30) additional days is requested. Good cause exists for this extension for the following reasons:

1. After multiple requests and delays caused in part by the Thanksgiving holiday, NIA and Hall are now meeting to discuss any interference issues and to strategize on addressing concerns raised by Hall in its Interference Complaint<sup>1</sup>. This includes establishing a testing schedule and driving the signal of the translator. The Parties have their first meeting scheduled for Wednesday, December 6, 2017. Attached hereto as

Exhibit 1 is correspondence between NIA's counsel and Hall's counsel and direct email between NIA and Hall regarding the coordination of a meeting to address this situation.

2. NIA has retained the service of local counsel, Jennifer L. McGhan of the firm McGhan Law LLC, to contact each Complainant listed in the Hall Complaint. Letters with informational questionnaires were sent via overnight delivery to each Complainant. Ms. McGhan has been in trial and therefore, copies of the Letters sent and the proof of delivery will be provided as a Supplemental filing to be submitted by Thursday, December 7, 2017. However, as of today, Ms. McGhan has not received any responses to her inquires.

3. Upon learning of the Hall Complaint, NIA, in good faith, voluntarily and immediately reduced power of its translator by fifty percent (50%) of authorized power. A request for Special Temporary Authority ("STA") was subsequently filed and has been approved by the Audio Division<sup>2</sup>. NIA shall continue operations at reduced power and shall, if necessary further modify this STA.

As the Parties are actively working on a resolution of this translator matter and the fact that NIA local counsel is waiting on responses from the Complainants, good cause exists for extending the period to respond to the Staff Letter.

Therefore, good cause having been shown, NIA respectfully requests an extension of time in which to respond to the Staff Letter until January 5, 2018.






Dear Anne & Susan:

I am in receipt of your e-mail regarding the conclusions of your client's engineer and his riding of the signal of W248CA, and his assessment that NIA's reduction in power is not effectively clearing-up the interference and further his recommendation NIA change channels. I spoke to Neal Ardman on this matter and we feel the best way (and the FCC proper way) to resolve this possible interference issue is to have Mr. Ardman and his consulting engineer and WPVC's consulting engineer meet to discuss possible engineering solutions and to set up a testing schedule. This testing would look at further reduction of power and, of course, Station "on-off" testing. Could you please provide contact information for whom Mr. Ardman should call to set up such a meeting?

John –

We and our client appreciate your client's quick reaction to the Commission's letter and their reduction in power with which W249CA is operating.

Unfortunately, however, the results of this reduction do not seem to have solved the issues. After our client was told of the power reduction, three of its staff, including its station engineer, travelled to the locations at which the WPCV signal had been experiencing interference. Unfortunately, our client found that there had been no improvement in the interference problems, even after your client indicated that the translator's power levels had been reduced. We understand that the station will need to work with your client to resolve the complaints, but given the lack of any improvement in the situation, our client believes that contacting the station staff would be somewhat premature.

Our client has had its consulting engineer run a study to determine whether there are any other channels to which your client's translator might relocate. He determined that there are three additional channels to which your client's translator possibly could be relocated, albeit at somewhat reduced power. Nonetheless, in light of the fact that the current reduction in power has not made any appreciable improvement in the interference situation, a change in channel might well be the best way to resolve the current problems.
