This is in reference to the STA request by WPRR, Inc. ("WPRR"), filed May 8, 2014, seeking an extension of the May 16, 2013 Special Temporary Authority ("STA") for temporary operation of WPJC while the licensee pursues a permanent site for the station. The licensee has filed construction permit application BPED-20140502AAA to use the STA site on a permanent basis, with different power and antenna height parameters.

The request for STA extension IS HEREBY GRANTED. Station WPJC may continue to operate with the following temporary facilities:


Geographic coordinates:	40° 52' 50.7" N, 88° 18' 2.4" W (NAD 1927)
Channel	202A (88.3 MHz)
Effective radiated power:	0.050 kilowatt (H)
Antenna height:	
above average terrain:	2 meters
above mean sea level:	205 meters
above ground:	9.2 meters

We expect that broadcast operations from this facility will be maintained through the term of this STA request.¹ Extensions may be requested and approved, provided the request demonstrates continued progress toward resuming licensed operation. WPRR must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

¹ The original STA request (BSTA-20130515AAZ) included a request for waiver of Section 73.1125, without explanation. Waiver of this rule was granted only to the extent that the main studio location can lie outside the 60 dBu contour of the STA facility authorized herein. However, WPJC's main studio must still meet all remaining provisions of Section 73.1125. For the purposes of this STA, the contour to be used for determining compliance with this rule shall be the licensed 60 dBu community service contour.

This authority expires on **November 19, 2014**.
