Dear Counsel:

This is in reference to the request filed June 20, 2011, on behalf of Townsquare Media Casper License, LLC ("TMC"). TMC requests further extension of the special temporary authority ("STA") granted on January 25, 2008, and modified on December 21, 2010, to operate Station KTWO during nighttime hours with its substantially adjusted nighttime directional pattern.¹ In support of the request, TMC states that has completed a Method of Moments ("MOM") proof of performance and that its application for license is pending.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made substantial progress toward restoring licensed operation. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KTWO may

continue to operate during nighttime hours with its substantially adjusted nighttime directional antenna system pending the processing of its pending application for modification of license supported by a MOM proof of performance pursuant to 47 C.F.R. Section 73.151(c). Operating parameters shall be maintained within $\pm 5\%$ current ratios and $\pm 3^\circ$ phase of the MOM-derived parameters, which shall be posted with the station license along with a copy of this letter. It will be necessary to reduce power or cease operation if complaints of interference are received. TMC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **February 8, 2012**.
