Dear Ms. Dortch:

On behalf of Calvary of Albuquerque, Inc. ("Calvary"), licensee of the above-referenced FM translator, this is to request a 60-day extension of time for filing a response to the FCC's June 6, 2012 letter seeking an amendment to the application. The Commission's letter points out that antenna structure registration is needed before further processing can be done.


On June 29, 2012 Calvary's engineer, Don Davis, filed a notice with the FAA seeking airspace approval. In his notice, Mr. Davis pointed out that the tower proposed in the application now pending before the FCC is an existing 72-ft structure on which the translator antenna would be side mounted. No increase in the height of the tower will occur as a result of this construction.

It is anticipated that processing of Calvary's notice (ASN 2012-ASW-3983-OE) will take 30 to 60 days. In order to accommodate this processing time, a 60-day extension of time is needed and requested.
