\* The shares of Class A common voting stock of Schurz Communications, Inc. ("SCI") beneficially owned by Franklin D. Schurz, Jr., James M. Schurz, Sr., Scott C. Schurz, Sr., and Mary Schurz, or their heirs (a total of 216,000 shares or approximately 75.2% of the outstanding votes of SCI) are held pursuant to a Voting Trust Agreement dated July 22, 2004. The duration of the trust is until December 31, 2054. The trustees of the trust are Franklin D. Schurz, Jr., Scott C. Schurz, Sr. and Todd F. Schurz. The trustees have equal voting powers; voting decisions are made by a majority of the trustees, except for certain actions, such as amendment of the articles or bylaws of SCI, which require a unanimous vote of the trustees; in the event of a voting tie, an unrelated third party would be named as an independent trustee to break the tie. Robin Bruni's shares of SCI stock are held in a revocable living trust of which she and her husband, James G. Bruni, are trustees. David C. Ray's shares of SCI stock are held by three trusts, of which he is the trustee.
