TECHNICAL NARRATIVE

This Technical Narrative and attached exhibits were prepared on behalf of Covenant Network, (“Covenant”), permittee of FM translator K247BU construction permit BNPFT-20130821AAF, Facility ID Number 144050, Mascoutah, Illinois.

Covenant herein proposes to modify W244BU construction permit BNPFT-20130821AAF by relocating to a different transmit location at Belleville, Illinois, changing the frequency to first adjacent channel 248D (97.5 MHz) and operate with 200 watts ERP directional at 27 meters AGL and 54 meters HAAT. The modified W247BU will be used as a fill-in translator for WRYT(AM), 1080 kHz, Facility ID Number 27556, licensed to Edwardsville. Covenant is the licensee of WRYT(AM).

Exhibit 10 demonstrates compliance with FCC Section 74.1201(g) for use as a Fill-In Translator. The proposed W247BU FCC F(50,50) 60 dBu contour is contained within the WRYT FCC 2.0 mV/M daytime contour and no part of the proposed W247BU FCC F(50,50) 60 dBu contour extends more than 25 miles from the WRYT transmitter site.

Therefore it is believed that this application is in compliance with Section 74.1201(g) of the Commission's rules.

Exhibits 13-A is a channel study using Section 73.207 spacings for Class A FM stations. The channel study indicates short spacings to five full power FM stations and one LPFM construction permit. Contour protection exhibits are only provided three full power stations and the LPFM construction permit. Contour spacing between the proposed W247BU and the other two full power FM stations were in excess of 25 kilometers and exhibits were not provided for WBBA-FM and KHZR. Exhibit 13-B is a contour protection map showing the proposed W247BU interfering contour does not overlap with the protected contour of WDLJ Channel 248A, Breese, IL. Exhibit 13-C demonstrates the proposed W247BU facility will not create prohibited interference to KYKY Channel 251C1, St. Louis MO. Exhibit 13-D is a contour protection map showing contour protection to a construction permit for KWAP-LP, Channel 249L1, Florissant, MO. Exhibit 13-E shows contour protection to KFTK Channel 246C1, Florissant, MO.

Exhibit 13-F shows compliance with Section 74.1233(a) "Common Overlap". The W247BU F(50,50) 60 dBu contours of the current construction permit and proposed modification overlap.

No interference will be delivered or received from any existing translator station or low power FM (LPFM) facility.

A study has been undertaken to show the proposed W247BU facility is in compliance with the Commission's radio frequency emission limits and is attached as Exhibits 17-A and 17-B.
