Rupert Murdoch's ability to appoint certain members of the Board of Directors of Cruden, Mr. Murdoch may be deemed to be a beneficial owner of the shares beneficially owned by the A.E. Harris Trust. Mr. Murdoch, however, disclaims any beneficial ownership of such shares.

of the Commission's rules, News Corporation certifies that Mr. Pompadur has duties wholly unrelated to the broadcast licensee subsidiaries of News Corporation. News Corporation also certifies that Mr. Shuman will recuse himself from any Board deliberations relating to the News Corporation's broadcast subsidiaries. Accordingly, neither Mr. Pompadur nor Mr. Shuman should be deemed to be a party to this application.

Cruden Financial Services, LLC ("Cruden"), a Delaware limited liability company, is the trustee of the A.E. Harris Trust, a Nevada trust. Cruden has the powers to vote and to dispose and to direct the vote and disposition of the News Corporation stock held by the A.E. Harris Trust.²

Actions by Cruden generally require the vote of at least five of its eight managing directors. Cruden's managing directors are divided into Classes A and B. K. Rupert Murdoch appoints all of the Class A and Class B Managing Directors; however, he must appoint as Class B Managing Directors individuals that are the designees of each of Prudence MacLeod, Elisabeth Murdoch, Lachlan Murdoch and James Murdoch (who are all children of K. Rupert Murdoch).³

KR-62, Ltd. ("KR-62") and KR-63, Ltd. ("KR-63"), both of which are Cayman Islands companies, are wholly-owned subsidiaries of 5-KR-11, Ltd., a Cayman Islands company ("KR-11"). KR-11 in turn is a wholly-owned subsidiary of The Kingdom Trust, a Cayman Islands trust that exists for the benefit of His Royal Highness Prince Alwaleed Bin Talal Bin Abdulaziz Alsaud ("HRH") and his family.

Under the terms of The Kingdom Trust, HRH has the power to appoint a majority of the directors of KR-11. As the sole shareholder of KR-62 and KR-63, KR-11 has the power to appoint the majority of the directors of KR-62 and KR-63. HRH currently is the sole director of both KR-62 and KR-63.

Accordingly, for purposes of Regulation 13-D-G under the Securities and Exchange Act of 1934, HRH can indirectly control the disposition and voting of the News Corporation shares held by KR-62 and KR-63. HRH is a citizen of the Kingdom of Saudi Arabia.

The information contained in this Exhibit No. 14 is based upon the Schedule 13-D that HRH filed with the United States Securities and Exchange Commission on September 5, 2005. News Corporation has requested that HRH and the entities identified herein supply additional information to confirm that the certifications contained in this application are true and correct with respect to each of them, given that they now hold attributable interests in News Corporation. If required following receipt of that information, News Corporation will further amend this application.
