ATTRIBUTABLE INTERESTS

Officers of Fisher Broadcasting Company are also officers of Fisher Radio Regional Group Inc. Sharon J. Johnston is the Secretary and David D. Hillard is the Assistant Secretary. Warren J. Spector, Executive Vice President and Chief Operating Officer, Fisher Communications, Inc., is also the sole director of both Fisher Broadcasting Company and Fisher Radio Regional Group, Inc.

O.D. Fisher Investment Company

O.D. Fisher Investment Company holds a 5.4196% interest in Fisher Communications, Inc. which in turn holds 100% of the common shares and 100% of the preferred shares of Fisher Broadcasting Company.

The Company does not take a direct, active role in the management or governance of Fisher Companies or of Fisher Broadcasting. The Company primarily is owned by the descendants of O. D. Fisher, one of the founders of Fisher Broadcasting, and their beneficiaries. No individual shareholder of the Company holds more than 14.39712% of the 1,198.83 outstanding shares of the Company, and thus none has an attributable interest in Fisher Broadcasting as a result of his or her shareholding in the Company.

The Commission should be aware that several of the above officers and directors hold direct ownership interests in Fisher Communications, Inc. and that Donald G. Graham, Jr., Donald G. Graham, III and Robin J. Campbell Knepper serve as directors of Fisher Communications, Inc.

GEORGE D. FISHER

George D. Fisher is one of three trustees of the D.R. Fisher Trust Under the Will of D.R. Fisher, Deceased, and has a lifetime income beneficial interest in that Trust. The D.R. Fisher Trust has an attributable interest in Fisher Communications, Inc. Mr. Fisher shares power to vote the stock owned by the Trust.

Mr. Fisher is the President and a Director of D. R. Fisher Company, which has a nonattributable interest in Fisher Communications, Inc. D. R. Fisher Company owns 232,928 shares of Fisher Communications, Inc., and Mr. Fisher has sole power to vote this stock. Mr. Fisher is also considered the beneficial owner of 11,200 shares owned by Mr. Fisher's mother.

WILLIAM O. FISHER

William O. Fisher is one of three trustees of the D.R. Fisher Trust Under the Will of D.R. Fisher, Deceased, and has a lifetime income beneficial interest in that Trust. The D.R. Fisher Trust has an attributable interest in Fisher Communications, Inc. Mr. Fisher shares power to vote the stock owned by the Trust.

ADDITIONAL INDIRECT INTERESTS AND CORPORATE OFFICERSHIPS

In addition to the direct ownership interests set forth above, the officers and directors of Fisher Communications, Inc. have additional indirect interests in Fisher Communications, Inc.

Donald G. Graham, Jr., Chairman of the Board and Director

Mr. Graham owns 36,960 shares of Fisher Communications, Inc. stock.

Mr. Graham is President and a Director of O.D. Fisher Investment Company, which has an attributable interest in Fisher Communications, Inc. Mr. Graham votes the stock owned by O.D. Fisher Investment Company.

Mr. Graham has voting and investment power as to 36,960 shares held by the estate of his deceased wife, Felecia A. Graham, of which he is the personal representative and trustee.

Mr. Graham has voting power over 28,901 shares held by the estate of Juanita Fisher Graham, of which he is co-executor.

Mr. Graham has prospective sole voting power to vote the shares of Fisher Communications, Inc. held by two trusts under the Will of Nellie Hughes Fisher and two trusts under the Will of O.D. Fisher, which have nonattributable interests in Fisher Communications, Inc., under proxies to be issued by Bank of America, Trustee: 381,104 shares.

Phelps K. Fisher

Phelps K. Fisher is the Treasurer of K. R. Fisher Investment Company, which has a nonattributable interest in Fisher Communications, Inc. K. R. Fisher Investment Company owns 134,872 shares of Fisher Communications, Inc., and Mr. Fisher has voting power over this stock.

Mr. Fisher is power of attorney for his two adult sons, one of whom owns 14,072 shares and the other owns 14,192 shares of Fisher Communications, Inc. and, as such, has voting power over this stock. Mr. Fisher's wife owns 23,000 shares.

Jean F. McTavish

Jean F. McTavish is one of three trustees Under the Will of Vivien S. Fisher, Deceased, and is also one of the two equal lifetime income beneficiaries of that Trust, which has a non-attributable interest in Fisher Communications, Inc. The trust under the Will of the late Ms. Fisher owns 61,160 shares of Fisher Communications, Inc. Mrs. McTavish shares power to vote that stock.

Jacklyn F. Meurk

Jacklyn F. Meurk owns 3,200 shares of Fisher Communications, Inc. stock jointly with her husband, Carl R. Meurk, and shares power to vote that stock.

Mrs. Meurk is the trustee Under the Will of Ethlyn Gaige Fisher, Deceased, which has a nonattributable interest in Fisher Communications, Inc. The Trust under the Will of the late Ms. Fisher owns 17,500 shares of Fisher Communications, Inc., and Mrs. Meurk has sole power to vote that stock.

Mrs. Meurk is also a general partner in the Meurk Family Limited Partnership, which has a nonattributable interest in Fisher Communications, Inc. The Meurk Family Limited Partnership

owns 11,440 shares of Fisher Communications, Inc., and Mrs. Meurk shares power to vote that stock.

Mrs. Meurk is a trustee of the Revocable Living Trust of Elaine Fisher Gourlie, which has a nonattributable interest in Fisher Communications, Inc. The Revocable Living Trust of Elaine Fisher Gourlie owns 25,123 shares of Fisher Communications, Inc., and Mrs. Meurk shares power to vote that stock.

Carol H. Fratt

Carol H. Fratt is an income beneficiary of a trust Under the Will of O.W. Fisher, Deceased, which has a nonattributable interest in Fisher Communications, Inc. The Trust under the Will of the late Mr. Fisher owns 57,690 shares of Fisher Communications, Inc. and Mrs. Fratt has no power to vote that stock.

Robin J. Campbell Knepper

Robin J. Campbell Knepper is an income beneficiary of a trust Under the Will of John L. Locke, Sr., Deceased, which has a nonattributable interest in Fisher Communications, Inc. The Trust under the Will of the late Mr. Locke, Sr. owns 143,272 shares of Fisher Communications, Inc. and Ms. Knepper has no power to vote that stock.

Ms. Knepper is Chairman of the Board and a Director of O.D. Fisher Investment Company, which has an attributable interest in Fisher Communications, Inc. Ms. Knepper does not vote the stock owned by O.D. Fisher Investment Company.

Ms. Knepper is an income beneficiary of a trust Under the Will of John L. Locke, Jr., Deceased, which has a nonattributable interest in Fisher Communications, Inc. The Trust under the Will of the late Mr. Locke, Jr. owns 38,904 shares of Fisher Communications, Inc. and Ms. Knepper has no power to vote that stock.

Ms. Knepper is Co-Trustee of Trust B Under the Will of Peggy Locke Newman, Deceased, which has a nonattributable interest in Fisher Communications, Inc. The Trust of the late Ms. Newman owns 213,560 shares of Fisher Communications, Inc., and Ms. Knepper shares power to vote these shares.

Ms. Knepper is Co-Trustee of Trust A Under the Will of Peggy Locke Newman, Deceased, which has a nonattributable interest in Fisher Communications, Inc. The Trust owns 14,080 shares of Fisher Communications, Inc., and Ms. Knepper shares power to vote these shares.

George F. Warren, Jr.

George F. Warren, Jr. is one of several trustees of the Lula Fisher Warren Trust, which has an attributable interest in Fisher Communications, Inc. Mr. Warren is an income beneficiary in that Trust. Mr. Warren shares power over the stock owned by the Trust. Mr. Warren is a first cousin of William W. Warren, Jr. Mr. Warren is a director of Warren Investment Company, which has

a nonattributable interest in Fisher Communications, Inc. Warren Investment Company owns 319,944 shares of Fisher Communications, Inc. stock, and Mr. Warren shares power to vote that stock.

William W. Warren, Jr.

Mr. Warren is an income beneficiary of the Lula Fisher Warren Trust Trust. Mr. Warren is a first cousin of George F. Warren, Jr. Mr. Warren is a director of Warren Investment Company, which has a nonattributable interest in Fisher Communications, Inc. Warren Investment Company owns 319,944 shares of Fisher Communications, Inc. stock, and Mr. Warren shares power to vote that stock.

FAMILY RELATIONSHIPS

Donald G. Graham, Jr. and Donald G. Graham, III, directors of Fisher Communications, Inc. are father and son.

CASCADE INVESTMENTS, L.L.C.

Cascade Investments, L.L.C. ("Cascade") is a 5.3% shareholder of Fisher Communications, Inc. All common stock held by Cascade may be deemed to be beneficially owned by William H. Gates, III, as the sole member of Cascade. Michael Larson, the manager and executive officer of Cascade has voting and investment power with respect to the common stock held by Cascade. Mr. Larson disclaims any beneficial ownership of the common stock beneficially owned by Cascade and Mr. Gates. Neither Cascade nor its principals hold attributable interests in any other broadcast facilities.
