

## EXHIBIT 6

### Description of Involuntary Transfer of Control

This application is one of seven applications being filed on FCC Form 316 seeking Commission consent for the *pro forma* involuntary transfer of control of television station licensee entities under the ultimate control of the Estate of Milton Grant (the "Grant Estate"). Bessemer Trust Company of Florida ("Bessemer") was appointed as the Personal Representative of the Grant Estate pursuant to a court order. FCC approval for the transfer of control applications filed in connection with the appointment of Bessemer as Personal Representative of the Grant Estate was obtained in 2011.<sup>1</sup>

Bessemer has submitted its resignation as Personal Representative of the Grant Estate. The court overseeing the administration of the Grant Estate has appointed a successor Personal Representative for matters relating to the Grant Estate which do not involve the stock of Grant Company, Inc. ("GCI"), the parent company in the ownership structure for the Grant television stations.

The court overseeing the administration of the Grant Estate has appointed Cabell Williams as the successor to Bessemer with respect to estate matters relating to the GCI stock. Mr. Williams will have the sole authority to vote and manage the GCI stock held in the Grant Estate. Mr. Williams' title in this regard is "Administrator Ad Litem" overseeing the GCI stock. The Court Order appointing Mr. Williams as successor to Bessemer with respect to the GCI stock is attached. This appointment will be effective upon FCC approval of this application and the related transfer of control applications.

Attached is a chart showing the ownership structure of the GCI television stations.

Upon the agreement of Bessemer Trust Company of Florida ("Bessemer"), current Personal Representative with respect to the Grant Company, Inc. ("GCI") stock, Thomas Grant, and Shirley Grant, and the Court being fully advised in the premises and hearing argument of counsel, it is

ORDERED AND ADJUDGED as follows:

1. Bessemer shall be replaced by CABELL WILLIAMS ("Mr. Williams"), to serve as the administrator ad litem as successor to Bessemer with responsibility to vote and manage the stock of GCI, effective upon the approval of said transfer of control by the FEDERAL COMMUNICATIONS COMMISSION ("FCC"). Bessemer, <sup>Grant Communication, Inc. and</sup> ~~and~~ Mr. Williams are hereby authorized and directed to immediately take such actions as may be necessary or appropriate to obtain such FCC approval.

2. Until FCC approval is received, Mr. Williams shall serve in an advisory capacity as a consultant, effective immediately.
