## CHANGES IN INTERESTS AS A RESULT OF TRANSFER

This application and other concurrently filed transfer of control applications request consent to the transfer of control of Univision Communications Inc. ("UCI"), and its direct and indirect licensee subsidiaries which hold various radio and television stations, from the Shareholders of Univision Communications Inc. to Broadcasting Media Partners Inc. ("Transferee"). The officers, directors, and attributable interest holders of Transferee are more fully described in Section IV, Question 6a.

UCI wholly owns,<sup>1</sup> either directly or indirectly, the licensees and permittees listed on the following attachment. UCI, Umbrella Holdings, LLC, and Umbrella Acquisition, Inc., a wholly owned subsidiary of Transferee, have entered into an Agreement and Plan of Merger ("Agreement") dated June 26, 2006, governing the proposed transaction.<sup>2</sup> A copy of the Agreement is attached hereto at Exhibit 6. Pursuant to that Agreement, after grant of the transfer of control applications and upon the closing of the merger, each share of outstanding common stock of UCI (other than (i) shares held in the treasury of UCI immediately prior to the effective time of the merger, (ii) shares owned by Umbrella Acquisition, Inc. or Transferee immediately prior to the effective time of the merger, and (iii) shares held by a stockholder who properly demands statutory appraisal rights) will be converted into the right to receive certain cash consideration from the Transferee. Each such share of UCI common stock being converted into the right to receive certain cash consideration will, by virtue of the merger, be automatically cancelled and cease to exist. Umbrella Acquisition, Inc. will be merged into UCI and UCI will become the wholly-owned subsidiary of Transferee. Each outstanding share of common stock of Umbrella Acquisition, Inc. will be converted into one share of common stock of UCI and will constitute the only outstanding shares of capital stock of UCI subsequent to the merger, thereby transferring control of UCI and its direct and indirect subsidiaries to Transferee.
