LETTERS TESTAMENTARY

THEREFORE, to the intent that the said Will may well and truly performed, we do give, grant and commit unto the said Dianne Biddle, the administration of all and singular the goods and chattels, rights and credits, of and belonging to the estate of said testator, with full power to take the same unto her hands and possession, and to ask, levy, recover and receive the same, wherever she may be in this State, hereby requiring and enjoining upon the said Dianne Biddle, to make a true and perfect inventory of all and singular the goods and chattels, rights and credits which have or shall come to her hands, possession or knowledge or into the hands or possession of any other person or persons, for her to exhibit the said inventory to our said Court within the time limited by law; to make a just and true account of her actions and doings therein, when thereto required by our said Court; and to well and truly pay and deliver all the legacies contained and specified in the said Will, so far as the said goods and chattels, rights and credits will extend and the law charge Dianne Biddle hereby confirming the said Executrix with full and ample authority to dispose of all and singular the said goods and chattels, rights and credits according to the tenor of the said Last Will and Testament, and the true intent and meaning
