

## MEMORANDUM OF UNDERSTANDING

Whereas the undersigned, Sound of Hope Radio Network Inc. (SOHR) of 333 Kearny Street, San Francisco, CA; Peralta Community College District (PCCD) of 333 East 8<sup>th</sup> Street, Oakland, CA.; and Chinese Culture and Art Heritage Foundation (CCAHF) of 1654 46<sup>th</sup> Ave., San Francisco, CA; have each filed an application with the Federal Communications Commission [FCC] for authorization to construct and operate low power FM radio stations on Chanel 245 to serve listeners in San Francisco and/or Oakland;

Whereas those applications, respectively file numbers BNPL20131114BOB; BNPL-20131107AOR and BNPL-20131114BQQ, are mutually exclusive as to the FCC granting either of them;

Therefore, SOH, PCCD and CCAHF agree to resolve the mutual exclusivity as follows:

1. To combine and aggregate their respective entitlements of complete points under the FCC rules in order to become licensees for Channel 245;
2. To enter into a time share agreement consistent with the Schedule shown below, if and upon prevailing as licensees for Channel 245;
3. To build and construct the transmission and antenna facilities at the antenna sites shown in their respective applications; or, at any other site as may be approved by the FCC;
4. To transmit a broadcast signal only according to the Schedule shown below or another substitute schedule as agreed upon and as specified in the licenses granted by the FCC and not to transmit any simulcast signal;
5. To broadcast programming for more than ten (10) hours weekly within and according to the Schedule shown below, or any substitute agreement as specified in the licenses; and
6. To amend their respective applications and file this agreement with the FCC on or before July 16, 2014.
