TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Miller Communications, Inc. ("MCI"), licensee of station WWBD, Channel 239C3, Bamberg, South Carolina. MCI is submitting an amendment to a minor change application for WWBD. The underlying application seeks to relocate the station and change the city of license to Isle of Palms, South Carolina. As such, a Radio Market Analysis is necessary. WWBD's new community of license is located in a metro county in the Charleston, South Carolina Arbitron Market (Market # 88). MCI does not control any other stations that are licensed to a community in the Charleston, South Carolina market. Further, the proposed WWBD 70 dBu does not have contour overlap with any other MCI facility in any rated or non-rated market. As such, a review of compliance in the Charleston, South Carolina rated market is being undertaken.

ARBITRON/BIA MARKET REVIEW

2. As shown on Exhibit #1, there are thirty-two AM and FM (commercial and non-commercial) stations listed in the Charleston, South Carolina (Market #88), thirty-three if WWBD is considered. MCI would be in control of one FM station in the market. The number of stations indicated falls in the thirty to forty-four stations tier of §73.3555(a)(1)(ii) of the Commission's rules, in both instances. At this level, common ownership or control of up to

seven stations, with no more than four in the same service, is permissible. Therefore, the minor change application for FM station WWBD in the Charleston, South Carolina market is in compliance with the ownership rules.

3. The foregoing technical statement was prepared on behalf of Miller Communications, Inc., by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.2. BIA database. All other data was extracted from the CDBS database. We assume no liability for errors or omissions in either database which may be adverse to the information contained herein.



His qualifications are a matter of record before the Federal Communications Commission. He has been active in Broadcast Engineering since 1979.


