Ownership Study

This ownership study is provided as an analysis for the aural broadcast markets formed by the proposed modification of WPKE-FM at Coal Run, KY to channel 221C3 in accordance with MB Docket No. 04-319.

WPKE-FM is not located within an Arbitron Metro area; as a consequence, the permitted common ownership is determined using the contour overlap methodology. The attached exhibits include the city grade contours, 3.16 mV/m (70 dBu) (FM) and 5 mV/m (AM), of all stations intersecting any of the mutually overlapping stations, including noncommercial facilities, and excluding any stations with a transmitter site greater than 92 km from any portion of the mutually overlapping area, as well as any commonly owned stations which do not mutually overlap the defined markets.

Exhibit E1 shows all of the commonly owned stations city grade contours. The mutually overlapping stations create three markets. Exhibits E2 through E4 show each of the mutually overlapping markets.

Market #1:

WPKE-FM-WBTH(AM)-WXCC(FM)-WDHR(FM)

3 FM and 1 AM with a total of forty-two (42) stations.

Market #2:

WPKE-FM-WEKB(AM)-WDGR(FM)-WXCC(FM)-WZLK(FM)-WLSI(AM)

3 FM and 3 AM in a total market of forty-five (45) stations.


Market #3:

WPKE-FM-WZLK(FM)-WPKE(AM)-WLSI(AM)-WXCC(FM)-WDGR(FM)

4 FM and 2 AM in a market of forty-four (44) stations excluding commonly owned stations.


In accordance with CFR §73.3555(a)(1)(ii) and (iii), the common ownership of the defined markets is permissible.




