1. PARTIES

2. MISCELLANEOUS DEFINITIONS

A. "Internet" - As used herein, the term Internet is understood as the commonly used reference for a network of computer networks publicly accessible worldwide.

B. "Web Site" - A Web Site, under this Agreement, is understood to mean a specific or unique physical or logical "address" on that portion of the Internet (and any successors thereto), commonly known as the "World Wide Web."

C. "Compositions" - Compositions includes all of the musical works which SESAC controls and for which SESAC is empowered to license the performance right during the Term of the Agreement, as defined below.

3. GRANT OF RIGHTS

A. As of January 01, 2002 ("Effective Date"), and subject to the limitations herein, SESAC grants to LICENSEE the non-exclusive right and license to publicly perform non-dramatic renditions of the Compositions, by transmission on or through the Web Site specifically described in the Schedule "B" Web Site (URL) Address field.

B. Any authorization made under this Agreement is limited to the United States, its territories and possessions and the Commonwealth of Puerto Rico ("U.S. Territory" or "U.S. Territory Rights"), unless LICENSEE elects to secure Foreign Territory Rights (defined in the Foreign Territory Addendum, available upon request).

4. LIMITATIONS OF RIGHTS

The rights granted herein specifically exclude:

A. The right to transmit the Compositions from web sites other than the Web Site described in Schedule "B," below;






