

EXHIBIT 13 DESCRIPTION OF TRANSACTION

On September 25, 2013, New Age Media of Pennsylvania, LLC, New Age Media of Pennsylvania License, LLC, New Age Media of Tallahassee, LLC, New Age Media of Tallahassee License, LLC, New Age Media of Gainesville, LLC, New Age Media of Gainesville License, LLC, and New Age Media Management, LLC (collectively, “**New Age**”) entered into an Asset Purchase Agreement (the “**Purchase Agreement**”) with Sinclair Television Group, Inc. (together with its subsidiaries, “**STG**”) for the sale of all of New Age’s commercial television stations and related facilities, as well as three other commercial television stations covered by the Purchase Agreement through Option Exercise Agreements.

In order to consummate the transactions contemplated in the Purchase Agreement, the parties identified below are contemporaneously filing a total of seven FCC Form 314 applications seeking the Commission’s consent to the assignment of the licenses of seven full-power television stations, four Class A television stations, one television translator station, and related auxiliary and other facilities to (a) STG, (b) subsidiaries of Cunningham Broadcasting Corporation (“**Cunningham**”), and (c) Deerfield Media (Tallahassee) Licensee, LLC, a company controlled by Stephen P. Mumblow (“**Deerfield**”). For ease of reference, these applications are described below as belonging to one of two groups: the New Age Applications (four applications) and the Option Party Applications (three applications).

The New Age Applications

The New Age Applications are as follows:

¹ WQMY(TV) operates as a satellite of WOLF-TV. STG will seek a continuation of the existing satellite waiver.

The Option Party Applications

The proposed transaction also contemplates the assignment of licenses of three (3) full-power television stations with respect to which New Age holds and has exercised purchase options: WSWB(TV), Scranton, PA (FAC ID 73374), WNBW-DT, Gainesville, FL (FAC ID 83965), and WTLF(TV), Tallahassee, FL (FAC ID 82735) licensed to MPS Media of Scranton License, LLC, MPS Media of Gainesville License, LLC and MPS Media of Tallahassee License, LLC, respectively (the “**Option Stations**”).

Under the Commission’s local television ownership rule, neither New Age nor STG (upon consummation of the transactions contemplated by the Purchase Agreement) may also own the Option Stations.³ As such, STG has assigned to Cunningham and Deerfield its right under the Purchase Agreement to acquire the Option Stations, subject to the Commission’s consent. New Age, in turn, has entered into Option Exercise Agreements with each of the licensees of the Option Stations in which, subject to the Commission’s consent, (i) MPS Media of Scranton License, LLC has agreed to convey television station WSWB(TV) directly to Cunningham,⁴ (ii) MPS Media of Gainesville License, LLC, has agreed to convey television station WNBW-DT, directly to Cunningham,⁵ and (iii) MPS Media of Tallahassee License, LLC has agreed to convey television station WTLF(DT) directly to Deerfield.⁶

New Age currently provides sales and other support services to the Option Stations pursuant to joint sales agreements (“**JSAs**”) and shared services agreements (“**SSAs**”). Upon consummation of the transactions contemplated by the New Age Applications and the Option

Accordingly, pursuant to the Assignment (attached as Exhibit 13 to the WTLH(TV) Form 314 application), STG has assigned to Cunningham the right to acquire certain license assets with respect to WTLH(TV) from New Age Media of Tallahassee License, LLC. Following consummation of the transactions contemplated by the New Age Applications, STG intends to provide sales and other support services to WTLH pursuant to a JSA and an SSA and will also enter into an assignable option with respect to WTLH(TV), copies of which are attached as Exhibit 13 to the FCC Form 314 applications pertaining to WTLH(TV).

⁵ Pursuant to the Assignment (attached as Exhibit 13 to the WNBW-DT FCC Form 314 application), STG has assigned to Cunningham the right to acquire certain license assets with respect to WNBW-DT from MPS Media of Gainesville License, LLC.

⁶ Pursuant to the Assignment (attached as Exhibit 13 to the WTLF(TV) FCC Form 314 application), STG has assigned to Deerfield the right to acquire certain license assets with respect to WTLF(TV) from MPS Media of Tallahassee License, LLC.

Party Applications, STG intends to provide sales and other support services to each of the Option Stations pursuant to JSAs and SSAs with each of Cunningham and Deerfield, and will enter into assignable options with respect to these stations, copies of which are attached as Exhibit 13 to the FCC Form 314 applications pertaining to the applicable Option Stations.
