Ownership Description.

Malara Broadcast Group of Fort Wayne Licensee LLC (“MBG Fort Wayne Licensee”) is the current licensee. This exhibit sets forth the parties to the application under the proposed ownership structure. The sole member of MBG Fort Wayne Licensee is Malara Broadcast Group of Fort Wayne LLC (“MBG Fort Wayne”). The sole member of MBG Fort Wayne is Malara Broadcast Group Inc. (“MBG Inc.”). The sole shareholder of MBG Inc. is TCM Media Associates LLC (“TCM Media”). The members of TCM Media are: (i) the estate of Anthony C. Malara, c/o Anthony J. Malara (70% member); (ii) Anthony J.
