

Changes in Interests

Legal Control of Volunteer State Community College resides with the Tennessee Board of Regents. The instant application is being filed to notify the Federal Communications Commission of the gradual change in the membership of the Tennessee Board of Regents of Volunteer State Community College between 2003 and 2007 and to obtain FCC consent for the change. Licensees are required to request Commission approval if membership of the controlling body of the licensee is changed by more than 50%, even if that change is incremental. This application is being filed to bring the licensee into compliance with the Commission's Rules.
