

## **MULTIPLE OWNERSHIP SHOWING**

With this application, CBS Radio Annapolis LLC (“CBS Radio”), an indirect wholly owned subsidiary of CBS Corporation (“CBS”), proposes to replace the WLZL antenna on the existing tower while making slight changes in antenna height, antenna pattern, and effective radiated power. CBS Radio’s proposed modification of WLZL will not change the number of stations controlled by CBS. As demonstrated below, upon grant of the application, CBS will still be in compliance with the Commission’s multiple ownership rules.

### **I. Local Radio Ownership Rule**

Following the proposed modification, CBS will remain in compliance with the local ownership rule.

Section 73.3555(a) of the FCC’s Rules provides that in a radio market with 45 or more full-power, commercial and noncommercial radio stations, a single entity may not have a cognizable interest in more than eight commercial radio stations in total and not more than five commercial stations in the same service (AM or FM). The Commission defines the relevant market to be the “Arbitron Metro,” in those markets so designated by Arbitron. *See 2002 Biennial Regulatory Review – Review of the Commission’s Broadcast Ownership Rules and Other Rules Adopted Pursuant to Section 202 of the Telecommunications Act of 1996*, 18 FCC Rcd 13620, 13712-13 (2003).

WLZL is home to the Washington, DC Arbitron Metro (the “DC Metro”). As shown on the attached BIA FCC Geographic Market Definition Report, there are 66 full-power commercial and noncommercial stations in the DC Metro. Therefore, the common ownership of eight radio stations, no more than five in the same service, is permitted in the DC Metro.

CBS currently controls the following six radio stations – one AM station and five FM stations – in the DC Metro:

In addition, while home to the Washington, DC Metro, WLZL is licensed to Annapolis, Maryland, a community located within the Baltimore Arbitron Metro (“Baltimore Metro”). Section 73.3555(a) of the FCC’s Rules provides that in a radio market with 30 to 44 full-power, commercial and noncommercial radio stations, a single entity may not have a cognizable interest in more than seven commercial radio stations in total and not more than four commercial stations in the same service (AM or FM).

As shown on the attached BIA FCC Geographic Market Definition Report, there are 36 full-power commercial and noncommercial stations in the Baltimore Metro. Therefore, the common ownership of seven radio stations, no more than four in the same service, is permitted in the Baltimore Metro.

CBS currently controls the following five radio stations in the Baltimore Metro:

Grant of this application will not change the number of stations that CBS controls in either the DC Metro or Baltimore Metro. As explained above, the common ownership of eight radio stations, no more than five in the same service, is permitted in the DC Metro, and the common ownership of seven radio stations, no more than four in the same service, is permitted in the Baltimore Metro. Therefore, CBS will still be in compliance with the local radio ownership rule following grant of this application.

## **II. Radio-Television Cross Ownership Study**

In addition to the radio stations listed above, CBS also owns WJZ-TV, Baltimore, Maryland. Therefore, the radio-television cross-ownership rule is implicated by the WLZL modification application. As shown below, CBS will remain in compliance with the radio-television cross-ownership rule following the proposed modification.

The radio-television cross-ownership rule, Section 73.3555(c), is triggered where there is the following signal encompassment:

- an FM station’s 60 dB $\mu$  (1 mV/m) contour encompasses the entire community of license of a commonly owned TV broadcast station; or

- an AM station's 2 mV/m contour encompasses the entire community of license of a commonly owned TV broadcast station; or
- a TV broadcast station's Grade A contour encompasses the entire community of a commonly owned radio station. Although the FCC Rules are silent regarding digital television service contours with respect to cross ownership, it is understood that the noise-limited DTV service contour (36 dB $\mu$  F(50,90)) is temporarily being utilized for this purpose. See *Letter to Stephen Diaz Gavin, Esq.*, 25 FCC Rcd 1851 (2010).

The radio-television cross-ownership rule is triggered in this case as to nine radio stations, including WLZL, and WJZ-TV. As shown on Figure 1, WJZ-TV's noise-limited contour entirely encompasses the communities of license of nine of these radio stations.<sup>1</sup> These nine radio stations include the five radio stations in the Baltimore Metro identified above, and four additional radio stations located in the adjacent Washington, D.C. Metro.

Under the radio-television cross ownership rules, the FCC does not count radio stations located in one Arbitron Metro toward the limits on the number of radio stations a party may own in another Arbitron Metro, even when the radio stations are within the contour of a commonly owned TV station unless the relevant contour of an out-of-market radio station triggers the rule. *Review of the Commission's Regulations Governing Television Broadcasting*, 16 FCC Rcd 1067, 1081 (2000); see also *Shareholders of Hispanic Broadcasting Corporation*, 18 FCC Rcd 18834, 18837 n.13 (2003). Here, as shown on Figure 1, the relevant contours of WJFK-FM, WPGC-FM, WIAD(FM), and WNEW(AM), each of which is located in the Washington, D.C. Metro, do not entirely encompass Baltimore, WJZ-TV's city of license. However, the relevant contour of WNEW-FM, home to the Washington, D.C. Metro, does entirely encompass Baltimore. Therefore, while WNEW-FM is an out-of-market radio station, it is included in the Baltimore Metro for purposes of the radio-television cross-ownership rule.

Because the Baltimore and Washington, D.C. radio stations are in two distinct radio markets, there are two separate radio-television markets as follows:

- In Baltimore, CBS currently controls and will continue to control one television station – WJZ-TV – and six radio stations – WJZ(AM), WJZ-FM, WLIF(FM), WWMX(FM), and WLZL(FM), which are licensed to cities in the Baltimore Metro, as well as WNEW-FM, which although located in the Washington, D.C. Metro, its 60 dB $\mu$  encompasses all of Baltimore.

<sup>1</sup> Figure 1 also shows the 60 dB $\mu$  contour and city of license for CBS's WJFK-FM, Manassas, Virginia. As shown on Figure 1, the WJZ-TV noise-limited contour does not entirely encompass Manassas, Virginia, the community of license of WJFK-FM, nor does WJFK-FM's 60 dB $\mu$  encompass Baltimore, Maryland, the community of license of WJZ-TV. Therefore, the radio-television cross-ownership rule is not triggered in this case by WJFK-FM.

- In Washington, D.C., CBS currently controls and will continue to control one television station – WJZ-TV – and four radio station – WIAD(FM), WNEW(AM), WNEW-FM and WPGC-FM.

Under the radio-television cross-ownership rule, an entity may control one television station and seven radio stations (to the extent permitted by the local radio multiple ownership rule) in a market containing at least 20 independently owned and operated media “voices,” if the common ownership of two commercial television stations in that market is permitted under the local television ownership rule. If the common ownership of two commercial televisions in the market is not permitted, then the radio-television cross-ownership limit is one television station and six radio stations. 47 C.F.R. § 73.3555(c). As shown in Table A, there are fewer than 8 independently owned and operating full-power commercial and noncommercial television stations in the Baltimore Nielsen Designated Market Area, which is the relevant market for purposes of the local television ownership rule. *See* 47 C.F.R. § 73.3555(b). Therefore, in the Baltimore Metro an entity may control one television station and six radio stations.

As shown in Table A, there are at least 20 independently owned media voices in each of the Baltimore and Washington markets. Therefore, common ownership of one television station and six radio stations in each of these radio-television markets is permitted, and CBS will continue to comply with the Commission’s radio-television cross-ownership rule following grant of this application.



