**Re: Notification of Tolling Construction Period for Station W256CO  
(now W260CY), Cleveland, OH (Facility ID No. 143930)**

Dear Ms. Dortch:

Friends of Christian Radio, Inc. ("FCR") and Common Ground Broadcasting, Inc. ("CGB") filed an assignment application with the Federal Communications Commission ("FCC") on July 29, 2016, seeking to assign the construction permit for unbuilt FM Translator Station W256CO (now W260CY), Cleveland, Ohio (Facility ID No. 143930) from FCR to CGB (File No. BAPFT-20160729ANL), which was granted on September 9, 2016, and consummated on October 20, 2016.

CGB filed a contingent "250 Mile Modification" application for W256CO on July 29, 2016 (File No. BMPFT-20160729ANZ), which was granted on September 9, 2016. The purpose of this modification is to allow CGB to rebroadcast WHK (AM), Cleveland, Ohio, on the translator.

The W256CO/W260CY Construction Permit is currently scheduled to expire on January 10, 2017. On October 7, 2016, however, a Petition for Reconsideration was filed by Media-Com, Inc. objecting to the grant of the modification application. Under Section 73.3598(b)(2) of the Commission's Rules, the period of construction for an original construction permit shall toll when

construction is prevented because the “grant of the permit is the subject of administrative or judicial review (*i.e.*, petitions for reconsideration and applications for review of the grant of a construction permit pending before the Commission...).”

CGB accordingly requests that the construction period for W256CO/W260CY be tolled until resolution of the pending administrative appeal.

CGB certifies that it is not subject to denial of federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. Section 862.
