Adopted October 15, 2007

In light of the Federal Communication's MM Docket No. 95-31, released February 28, 2001, Columbus County Schools, by unanimous consent of its members, hereby certifies the following:

1. In any proposed station whereby Columbus County Schools has claimed comparative points as an Established Local Applicant, it will maintain such localism within the meaning of Title 47 CFR 73.700 of the Commission's rule.
2. In any proposed station whereby Columbus County Schools has claimed comparative points for Diversity of Ownership, it will require itself to maintain the diversity within the meaning of Title 47 CFR Section 73.7003 (b) (2) and Title 47 CFR Section 73.3555 of the Commission's rule.

The Columbus County Board of Education, in session on October 15, 2007, adopted the above policy.

MINUTES OF MEETING OF COLUMBUS COUNTY BOARD
OF EDUCATION - JULY 2, 1936.



The Columbus County Board of Education met in the office of the said Board on July 2nd, 1936, at 2 P. M., according to adjournment with the following members present:

F. T. Wooten, Chairman
A. P. Rogers
R. G. Burns
I. T. Newton
Carl Meares

The Minutes of the Meeting held May 4th, 1936, were read and upon motion of A. P. Rogers, seconded by R. G. Burns, and unanimously approved by all members present, ordered certified as correct.

A petition signed by a number of citizens of the Fair Bluff community and patrons of the Fair Bluff and Worley Schools, requesting that:

"We the patrons of the Fair Bluff Colored School and the Worley Colored School of District No. 4, present the following proposals for our schools improvement.

- (1) We propose to consolidate the Worley School and the Fair Bluff School.
- (2) We propose to raise our school to a two year Junior High School.
- (3) We hold that these proposals will give our children better training for their immediate needs at no extra cost to the county. We pledge our unyielding efforts to realize these aims and humbly beg your approval and assistance;" was presented to the Board for consideration. Four colored patrons appeared in person before the Board in behalf of the proposal. After a lengthy discussion by all members present, it was ordered that the petition be denied due to the fact that such a proposal would be contrary to the policy of the State School Commission, and against the reorganization program of the County Schools, and in addition such a proposal would increase the cost of operation and at the same time destroy the standard high school for negroes at Chadbourn. This above motion was made by Carl Meares, seconded by R. G. Burns, and unanimously approved by all members present.

On motion of A. P. Rogers, seconded by Carl Meares, and unanimously approved by all members present, it was ordered that, the Columbus County School calendar for the year 1936-37, both white and colored, be as follows, subject to change for any unforeseen necessity:
