It is our understanding that a response to this question is required only if the Commission's equity debt plus ("EDP") rule applies, *i.e.*, only if an otherwise non-attributable party (1) holds equity and/or debt interests that in the aggregate exceed 33% of the total asset value of the subject broadcast licensee, and (2) either (i) supplies over 15% of the total weekly broadcast programming hours of the station or (ii) holds an attributable interest in another media interest that is subject to the multiple ownership/cross-ownership rules and that is in the same market as the subject licensee. None of the interests identified in this exhibit is attributable by virtue of the EDP rule. Accordingly, no EDP information is shown. In the interest of clarity, however, the percentage equity interest is shown for each party to the application.
