Schedule 1.2(b)
Real Property

1. Month to month verbal lease, by and between Plaza Hotel and Radio Nevada Corp., cancellable by either party on 30 days notice.

2. Lease and Option Agreement, to be negotiated between Buyer and Seller, for Buyer's use of existing KDWN transmitter site, including transmitter building and tower. Lease terms: lease term shall be for 36 months after the date of Closing of the Purchase Agreement, non-renewable, at a rent of \$3,000 per month. Buyer shall pay all tower site utilities, maintenance, and its own insurance. The parties will indemnify each other from liability arising from their own actions or failure to act. Buyer shall have the option to purchase the transmitter site, in fee simple, for \$5,000,000, exercisable by Buyer at any time during the term of the Lease and Option Agreement, provided that the sale is consummated on or before the 30th day after the end of the term of the lease. The option will terminate in the event that the option is not exercised during the term of the lease, or the purchase does not close on or before the 30th day after the end of the term of the lease. The purchase price shall be paid in cash with a 10% good faith escrow deposit to be paid by Buyer upon exercise of the option.
