

Exhibit 16 - Other Authorizations

This application requests Commission consent for the transfer of control of Lamco Communications, Inc. (“Lamco”), from the Shareholders of Lamco to BlueStone TV Holdings Inc. (“BlueStone Holdings”). The transfer of control will occur as the result of a merger of Lamco and BlueStone Merger Co. (“Merger Sub”), a wholly owned subsidiary of BlueStone Holdings. After the merger, Lamco will be the surviving entity as a wholly owned subsidiary of BlueStone Holdings.

Through its wholly owned subsidiary, the DGH Company (“DGH”), Lamco is the ultimate parent of five Commission licensees: Appalachian Broadcasting Corporation, Abilene-Sweetwater Broadcasting Company, California Broadcasting, Inc. and Eagle Communications, Inc. (the “Lamco Licensees”). ^{1/} Each of the Lamco Licensees is a wholly owned subsidiary of DGH.

^{1/} Lamco is also the ultimate parent, through DGH, of Eastern North Carolina Broadcasting Corporation (“Eastern”), licensee of WCTI-TV, New Bern, NC (Facility ID No. 18334) and its paired licensed digital television (“DTV”) station, WCTI-DT (“WCTI”). However, Eastern will assign the WCTI license to Newport Broadcasting Inc. (“Newport”) immediately prior to consummation of the merger of Lamco and Merger Sub and control of the FCC license for WCTI will *not* be transferred as part of the merger proposed in this application. An application on FCC Form 314 seeking consent to the assignment of the WCTI license from Eastern to Newport is being filed either simultaneously with, or shortly after, this application.

The restrictions contained in Section 73.3555(d) of the Commission’s Rules (the “Daily Newspaper Cross-Ownership Rule”) make it necessary for Eastern to assign the WCTI license to Newport because Providence Equity Partners IV L.P., Providence Equity Operating Partners IV L.P. and their affiliated entities, which have attributable interests in BlueStone Holdings (the proposed transferee in this application), also will have attributable interests in Freedom Communications Holdings, Inc., the indirect parent of the proposed licensees of certain television stations in a transaction that is currently pending before the Commission (*see* FCC File Nos. BALCT/BAPLCT-20031223ACV-AEK; BALCT-20031224AAT) (the “Freedom Transaction”). As part of the Freedom Transaction, Providence Equity Partners IV L.P., Providence Equity Operating Partners IV L.P. and their affiliated entities will also acquire attributable interests in daily English-language newspapers serving the same communities as those served by WCTI (*i.e.*, the New Bern Sun Journal, the Jacksonville Daily News, and the Kinston Free Press).
