

## **TRANSFER OF CONTROL**

Pursuant to Commission authorization in FCC File BAL-19960311ED<sup>1</sup> (a long form application), the license for station WFNO (AM), Norco, has been held by entities under the majority ownership and control of William M. Metcalf, Jr. Subsequently,

pursuant to Commission authorization in BAL-19981008GH,<sup>2</sup> the license for WFNO was assigned to WFNO, L.L.C., over which Mr. Metcalf held control and of which Mr. Metcalf owned 90%. Alan Campell owned 10%; then,

pursuant to Commission authorization in FCC File BTC-20000828AQD, control of WFNO, L.L.C. was transferred to the Metcalf Family Limited Partnership (90%), and Alan Campell (10%).<sup>3</sup>

Similarly, pursuant to Commission authorization in FCC File BAL-19960206EB (a long form application), the license for station WGSO (AM), New Orleans has been held by entities under the majority ownership and control of William M. Metcalf, Jr. And, similarly, subsequently,

pursuant to Commission authorization in BAL-19981008GI, the license for WGSO was assigned to WGSO, L.L.C., over which Mr. Metcalf held control and of which Mr. Metcalf owned 90%. Alan Campell owned 10%; then,

pursuant to Commission authorization in FCC File BTC-200823ACS, control of WGSO, L.L.C. was transferred to the Metcalf Family Limited Partnership (90%), and Alan Campell (10%).

For business reasons, Mr. Metcalf seeks consent to the substitution of MC Media, L.L.C. as the owner of WFNO, L.L.C. and WGSO, L.L.C. MC Media, L.L.C. is owned by the Metcalf Family Limited Partnership (87.3%), Alan Campell (9.7%), and Todd Matherne (3.0%). William M. Metcalf remains the majority owner of, and in control of, the Metcalf Family Limited Partnership.

Upon Commission consent to the contemplated transactions, control of stations WFNO (WFNO, L.L.C., Licensee) and WGSO (WGSO, L.L.C., Licensee) will continue to be vested in the Metcalf Family Limited Partnership, except through ownership of MC Media, L.L.C., [comprised of the Metcalf Family Limited Partnership (87.3%), Alan Campell (9.7%) and Todd Matherne (3%)], through substitution of MC Media as a member of WFNO, L.L.C. and WGSO, L.L.C., rather than directly.

Both WFNO and WGSO will remain under the control of William M. Metcalf, as they have been since the long-form applications granted by the Commission in 1996. Thus, the Commission's consent to the transactions is properly sought on Commission Form 316. The transaction is *pro-forma* only.
