Assignor proposes to assign the construction permit for NEW(FM) to its commonly owned and controlled affiliate, Christine CP Co, LLC (“Assignee”).

As depicted on *Figure 1* attached hereto, Assignor and Assignee are both wholly-owned subsidiaries of GoodRadio.TV License Holdings, LLC (“License Holdings”). Each of the following entities are members of License Holdings and hold the interests listed in *Figure 1*: Dean Radio.TV Company – Grinnell, LLC, Dean Radio.TV Company – Newton, LLC, Dean Radio.TV Company – Fairfield, LLC, GoodRadio.TV – Missouri, LLC, Christine Radio, LLC, and Dean Radio.TV Company – Clinton, LLC.

Figure 1 – GoodRadio.TV, LLC Ownership Structure


