<sup>4</sup> The Stanley S. Hubbard Revocable Trust (the “SSH Revocable Trust”) holds voting and non-voting stock in Hubbard Broadcasting, Inc. (“HBI”). This stock represents 15.26% voting control of HBI. Stanley S. Hubbard and his wife, Karen H. Hubbard, are the Co-Trustees of the SSH Revocable Trust; however, Stanley S. Hubbard retains the right to amend or revoke the SSH Revocable Trust at any time and the right to change Trustees at any time. Accordingly, Stanley S. Hubbard individually controls the SSH Revocable Trust, and the voting interest held by such Trust is being reported as held by Stanley S. Hubbard, individually. As noted in footnote 8 below, Stanley S. Hubbard controls a majority of the voting stock of HBI.

<sup>5</sup> Karen H. Hubbard holds HBI non-voting stock through a revocable trust that she controls.

<sup>6</sup> Each of Kathryn H. Rominski, Stanley E. Hubbard, Virginia H. Morris and Robert W. Hubbard has created separate revocable trusts, wherein each retains, individually with respect to their separate trust, the right to amend or revoke or change Trustees at any time. Each of the foregoing named stockholders is a Trustee of her or his separate revocable trust, and each such trust holds 8.96% of voting control of HBI. Each such revocable trust shares the social security number of the foregoing named stockholder who created such trust. Each revocable trust is individually controlled by the foregoing named stockholder who created such revocable trust. Therefore, the voting interest in HBI held in each such revocable trust is being reported as being held by the foregoing named stockholder who created such trust.

<sup>7</sup> Each of Kathryn H. Rominski, Stanley E. Hubbard, Virginia H. Morris and Robert W. Hubbard, as Trustees, controls a 9.32% non-voting interest in HBI. Julia H. Coyte similarly controls, as Trustee, an 8.31% non-voting interest in HBI. These non-voting stock interests are held in individually controlled Grantor Retained Annuity Trusts (each, a “GRAT”) created by each of these individuals. Each GRAT shares the social security number of its respective individual stockholder and those non-voting interests are being reported as held by those individuals. In addition, each of these Hubbard family members has created a life insurance trust that holds a small (approximately 0.5%) non-voting stock interest in HBI and these interests are being reported as held by those individuals.


<sup>8</sup> The Kinnimaka Trust Company (“Kinnimaka”), a South Dakota private trust company, is the sole trustee of the Stanley S. Hubbard Trust, the Stanley E. Hubbard Residuary Trust No. 1, and the Stanley E. Hubbard Grandchildren’s Trust FBO Alice Liptak et al. (the “Three Trusts”). The SSH Revocable Trust is the sole shareholder of Kinnimaka and Stanley S. Hubbard is the sole trustee of the SSH Revocable Trust for the purpose of controlling Kinnimaka, and through Kinnimaka, voting the HBI voting stock held by the Three Trusts. The Three Trusts also hold HBI non-voting stock. The officers and directors of Kinnimaka are as follows:

- Stanley S. Hubbard – Chairman, President
- David A. Jones – Director, Vice President
- C. Thomas Newberry – Director, Vice President, Treasurer and Cashier
- Gary R. Macomber – Director and Secretary
- P. Daniel Donohoe – Director and Assistant Vice President
- Stephen R. Litman – Director and Assistant Vice President.

Stanley S. Hubbard controls 55.19% of the voting stock of HBI through his control of the SSH Revocable Trust and his control of the Three Trusts through the SSH Revocable Trust owning 100% of the stock of Kinnimaka (the sole Trustee of each of the Three Trusts).
